# 2024 FARM BILL

Farmers, the rural economy and communities of every size rely upon a forward-looking and fully-funded farm bill. NASDA will continue advocating for a farm bill that provides farmers and ranchers a reliable safety net and consumers access to the safest and most affordable food supply. The next farm bill must remain unified – securing a commitment to American agriculture and the critical food and nutritional assistance programs for those who need it most. NASDA's priorities for the next farm bill are:

- Agricultural research
- Animal disease prevention
- Conservation and climate resiliency
- Cyber security
- Food safety
- Hemp promotion
- Invasive species mitigation
- Local food systems
- Specialty crop block grant funding
- Trade promotion



## **FOOD SAFETY & FOOD SUPPLY CHAIN**

NASDA will continue advocating for funding state Food Safety Modernization Act programs as state departments of agriculture are the front line of protection for consumers when it comes to food safety, playing a vital role in implementing food safety laws.



#### **LABOR REFORM**

NASDA continues to advocate for a framework that provides for a legal, reliable workforce that supports the agricultural industry and treats workers with respect.



#### PESTICIDE REGULATION

It is crucial to maintain a commitment to scientifically-sound processes in the regulatory system that allows for safe, effective products. NASDA will continue engaging with the U.S. Environmental Protection Agency to ensure science-based standards and state input are included when developing regulatory action regarding pesticides.



## **PFAS**

Per- and polyfluoroalkyl substances (PFAS) are a general name for a class of manmade chemical compounds that are highly resistant to environmental degradation. NASDA is engaging with federal agencies to develop a risk communication strategy, increase research and develop a roadmap for cross-agency collaboration.

Through NASDA's cooperative agreement with USDA's National Agricultural Statistics Service, NASDA employs 2,400 enumerators across the U.S. to collect agricultural data essential to inform agricultural communities, businesses, policymakers and consumers. This data, found in crucial reports such as the Census of Agriculture, is vital for maintaining a strong agricultural economy and guiding everything from investment strategies and production and marketing decisions to fostering international trade.
